The environmentally friendly design and continuous improvement of our activities and services are carried out in this spirit, in order to contribute to the provision of opportunities for future generations and to a liveable environment. As a commitment to environmental awareness, Gravic Hungary Ltd. operates according to the international standard EN ISO 14001:2015. In this way, I commit myself every day to provide the necessary resources to the company's employees to continuously maintain and improve their environmentally conscious activities with my full support.

We have assessed the environmental impacts of our printing activities and the environmental resources we use to achieve them. Our company aims to make the most efficient use of the resources we use and to reduce the amount of waste generated by our production activities, while keeping the proportion of recyclable waste as high as possible.

Our commitment to environmental responsibility is based on the following principles:

- ✓ We are committed to reducing pollution, environmental pressures and negative impacts on the environment, i.e. protecting the environment.
- ✓ We continuously review our environmental management system and performance to meet our compliance obligations and regularly improve it in the light of the results achieved.
- We take environmental components into account in our business decisions and strategy.
- ✓ We are committed to complying with all applicable environmental legislation and international conventions, and to meeting the specific needs of our customers.

Our employees are continuously trained to become familiar with our company's environmental policy and objectives, emphasising their own responsibility to protect the environment.
- 3. Our goals and objectives are set out in programmes, which are reviewed, evaluated and defined annually in order to meet the requirements of our environmental policy and the needs of the environment around us.
- 4. We give high priority to recyclable waste, collect it selectively and do our utmost to ensure its additional use / re-use/recycling as far as possible, in continuous cooperation with specialised companies.

- 6. In manufacturing processes, we continuously assess the consistency of quality and environmental impact, by keeping scrap levels low and introducing continuous improvement measures in production.
